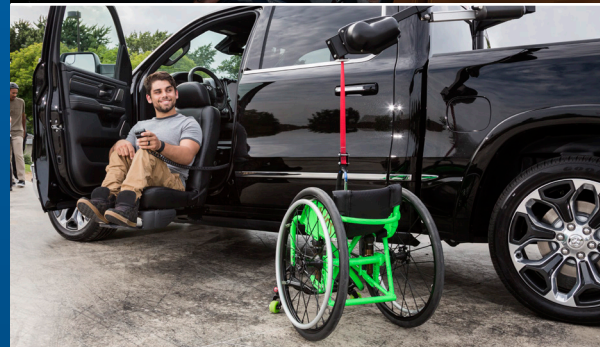

Adaptive equipment must be installed within six months of vehicle purchase or lease. An application form along with supporting documents must be submitted to DriveAbility Program Headquarters within 60 days of complete installation of adaptive equipment. Factory-optional equipment is not reimbursable. A prescription or note from a licensed medical doctor is required for reimbursement of certain adaptations. Conversions to eligible models may be reimbursed up to a maximum of \$1,000. Running boards qualify for reimbursement up to a maximum of \$400. Alerting devices qualify for reimbursement up to a maximum of \$200. Payment to the individual DriveAbility Program customer who purchased through a mobility dealer will be mailed within six weeks after receipt of an approved application form and all required documentation. Not all vehicles and adaptive equipment are eligible. Additional requirements apply. See dealer or visit www.StellantisDriveAbility.com for more details.
